The Fund is managed by Invesco Management S.A., part of the Invesco Group.

### Objectives and Investment Policy

- The objective of the Fund is to achieve income and long-term capital growth.
- The Fund may invest in debt instruments which are in financial distress (distressed securities).
- The Fund may also gain exposure to securitised debt.
- The Fund intends to invest primarily in shares of companies and debt instruments which have exposure to real estate related activities.
- The Fund does not invest directly into real estate.
- The Fund invests worldwide.
- The Fund is actively managed and is not constrained by a benchmark. The performance of the Fund may be compared to a benchmark, for comparison purposes only, where a suitable comparator exists (please refer to the Past Performance section below where a benchmark will be displayed if relevant).
- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).
- Any income from your investment will be paid quarterly, out of gross income.

### Other Risks

- As this Fund is invested in a particular sector, you should be prepared to accept greater fluctuations in the value of the Fund than for a fund with a broader investment mandate.
- The Fund may use derivatives (complex instruments) in an attempt to reduce the overall risk of its investments or reduce the costs of investing, although this may not be achieved.
- The Fund may charge a portion, or all of its fees and expenses against the capital, reducing the capital and constraining future capital growth.
- The Fund may hold a large amount of Asset Backed Securities (ABS) (complex instruments) as well as other lower quality debt securities which may impact the liquidity of the Fund under certain circumstances.

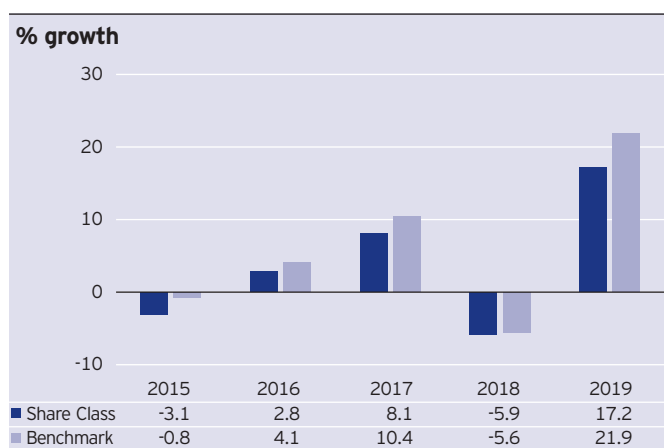
## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

- Any entry charge shown is a maximum figure. Where charges are shown, in some cases you might pay less; you can find this out from your financial adviser or distributor.
- The ongoing charges figure is based on annualised expenses for the period ending August 2019. This figure may vary from year to year. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- There is currently a discretionary cap of operating expenses at a maximum of 0.05% in place. This figure forms part of the ongoing charge and may positively impact the performance of the Share Class.
- If you switch funds, you will pay a maximum switching charge of 1% on your new fund.
