Invesco China New Perspective Equity Fund (the "Fund") A sub-fund of Invesco Funds (the "Umbrella Fund") Class C accumulation - HKD (ISIN: LU1775966390) (the "Share Class")

The Fund is managed by Invesco Management S.A., part of the Invesco Group.

Objectives and Investment Policy

- The objective of the Fund is to achieve long-term capital growth.
- The Fund invests primarily in shares of companies in China.
- China refers to Hong Kong SAR, Mainland China and Macau SAR.
- Reference to China New Perspective is intended to relate to the continued evolution of China's economy, whereby the Investment Manager will seek to capture the
 different opportunities that drive economic growth as they arise and change over time.
- The Fund may use derivatives (complex instruments) to manage the Fund more efficiently, with the aim of reducing risk, reducing costs and/or generating additional capital or income.
- The Fund is actively managed and is not constrained by its benchmark, the MSCI China 10/40 Index (Net Total Return), which is used for comparison purposes. However, the majority of the Fund's holdings are likely to be components of the benchmark. As an actively managed fund, this overlap will change and this statement may be updated from time to time.
- The Fund has broad discretion over portfolio construction and therefore securities, weightings and risk characteristics will differ. As a result, it is expected that over time the risk return characteristics of the Fund may diverge materially to the benchmark.
- In addition to the charges set out in the Charges section below, the Fund will incur portfolio transaction costs which are paid from the assets of the Fund. These may have a material impact on your returns.
- Please refer to the Past Performance section below where a benchmark will be displayed if relevant.
- The Fund promotes environmental, social and governance (ESG) criteria as covered under Article 8 of the Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector.
- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).
- Any income from your investment will be reinvested.


Other Risks

- The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.
- The lack of common standards may result in different approaches to setting and achieving ESG objectives. In addition, the respect of the ESG criteria may cause the Fund to forego certain investment opportunities.
- Shares of companies are generally considered high risk investments and may result in fluctuations in the value of the Fund due to external factors.
- Return on your investment may be adversely affected by variations in exchange rates.
- It may be difficult for the Fund to buy or sell certain instruments in stressed market conditions. Consequently the price obtained when selling such instruments may be lower than under normal market conditions.
- The Fund may use Stock Connect to access China A Shares traded in Mainland China. This may result in additional liquidity risk and operational risks including settlement and default risks, regulatory risk and system failure risk.
- As this Fund is invested in a particular geographical region, you should be prepared to accept greater fluctuations in the value of the Fund than for a fund with a broader geographical investment mandate.
- The Fund invests in a limited number of holdings and is less diversified. This may result in large fluctuations in the value of the Fund.
- The Fund may use derivatives (complex instruments) in an attempt to reduce the overall risk of its investments or reduce the costs of investing, although this may not be achieved. The use of derivatives transactions may expose the Fund to counterparty risks that may result in losses to the Fund associated with the bankruptcy or insolvency of a counterparty.
- This Share Class is denominated in a different currency than the base currency of the Fund and is not intended to be hedged. Therefore, return on your investment may be adversely affected by variations in exchange rates between the two currencies.
- As a large portion of the Fund is invested in a less developed country, you should be prepared to accept significantly large fluctuations in the value of the Fund.
