The Fund is managed by Invesco Management S.A., part of the Invesco Group.

Objectives and Investment Policy

- The objective of the Fund is to provide a positive total return over a market cycle with a moderate correlation to traditional European equity indices.
- The Fund intends to gain exposure primarily to shares of European companies that it believes will either outperform (long positions), or underperform (short positions) relative to each other.
- The Fund may make significant use of derivatives (complex instruments) in order to (i) reduce the risk and/or generate additional capital or income and/or (ii) meet the Fund's investment objectives by generating varying amounts of leverage (i.e. where the Fund gains market exposure in excess of the net asset value of the Fund).
- The Fund may be invested up to 100% of its net asset value in cash, cash equivalents and money market instruments where exposure is taken via the use of derivatives (complex instruments).
- The Fund is actively managed and is not constrained by a benchmark. The performance of the Fund may be compared to a benchmark, for comparison purposes only, where a suitable comparator exists (please refer to the Past Performance section below where a benchmark will be displayed if relevant).
- You can buy and sell shares in the Fund on any Dealing Day (as defined in the Prospectus).
- Any income from your investment will be reinvested.


